2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

- * Limitations on Reverse-Engineering, Decompilation, and Disassembly. You must not reverse-engineer, decompile, or disassemble the SOFTWARE PRODUCT.
- * Rental. You must not rent or lease the SOFTWARE PRODUCT.
